# Who are Energean?

- An upstream E&P Company with its headquarters in Greece,
- Founded in 2007 with the purpose of acquiring the 300 mln bbl Prinos field and its undeveloped satellites,
- Successfully grown over the last decade through a series of exploration and development based acquisitions in:
  - Egypt,
  - Greece,
  - Montenegro and
  - Israel.
- Mission: “To be a leading E&P Company in the Eastern Mediterranean”
- Successfully IPO’d on the London Stock Exchange (LSE) in March 2018:
  - \$460 mln raised – used to fund development projects in Greece and Israel plus existing exploration commitments.
- Entered the FTSE-250 index in May 2018,
- Parallel listing on the Tel Aviv stock market planned for July 2018.

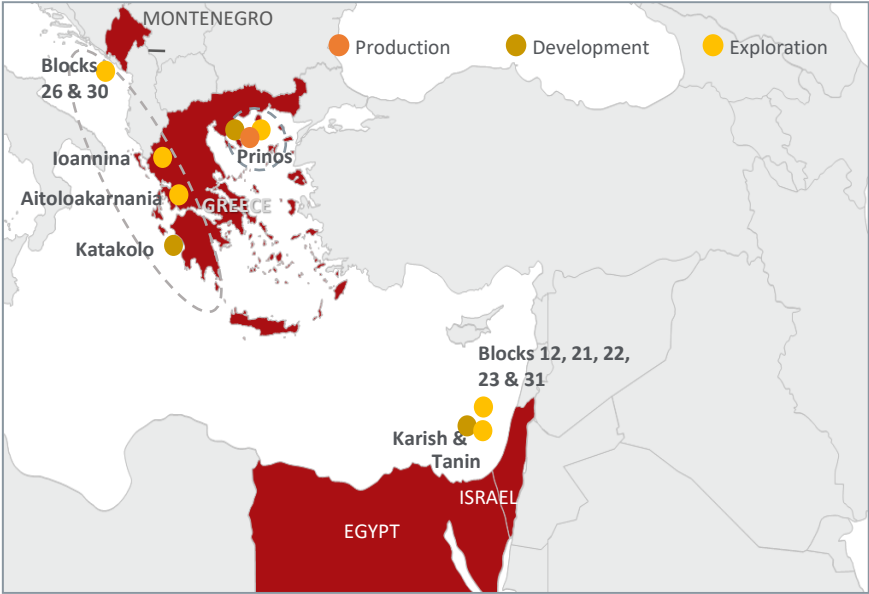

- Not only did Ancient Greece invent Democracy, Medicine, Philosophy and Cartography – it also managed the first ever oil development project.....

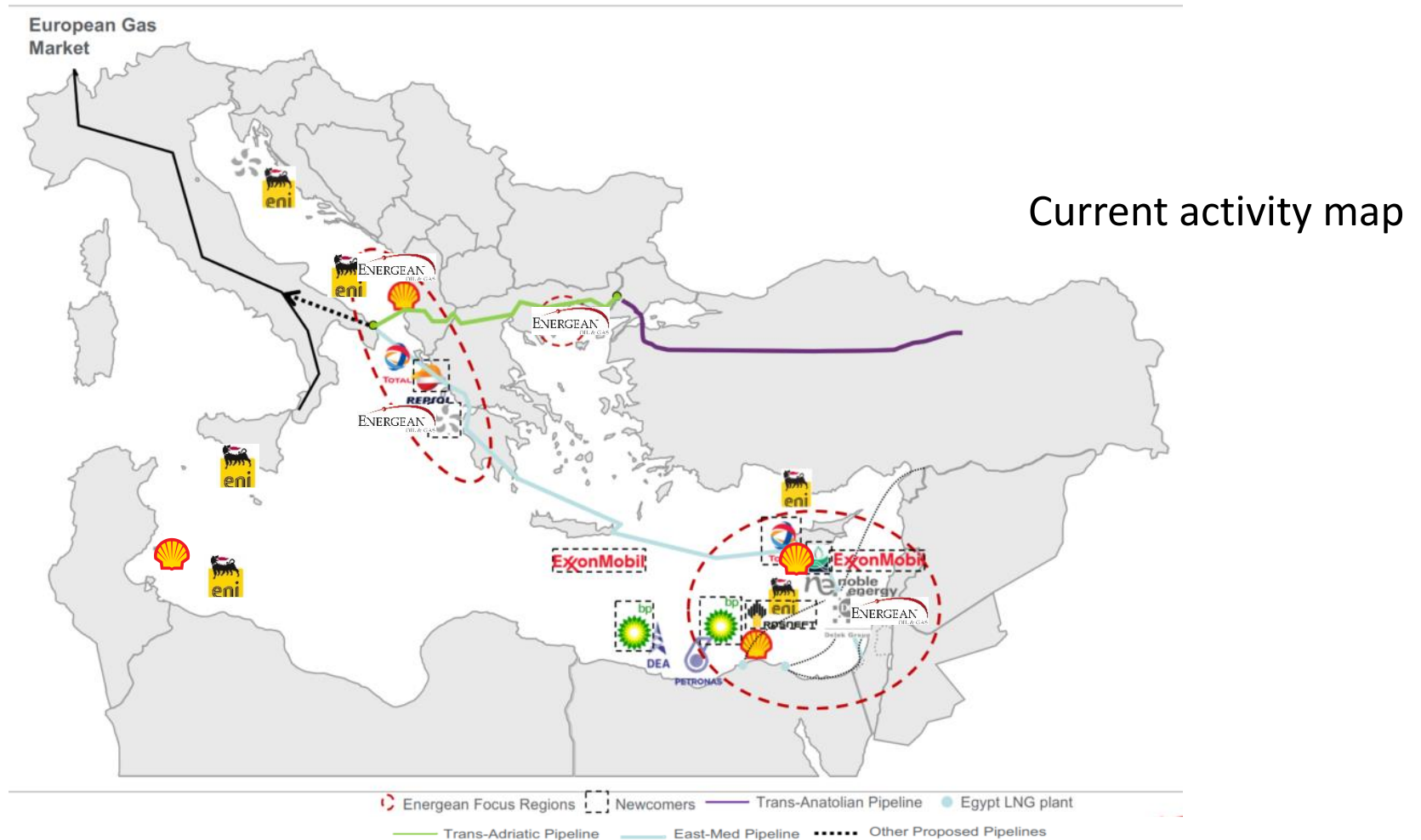

- ...2500 years later the Oil and Gas industry in the Eastern Mediterranean has progressed significantly but remains relatively under exploited compared with other parts of the World.

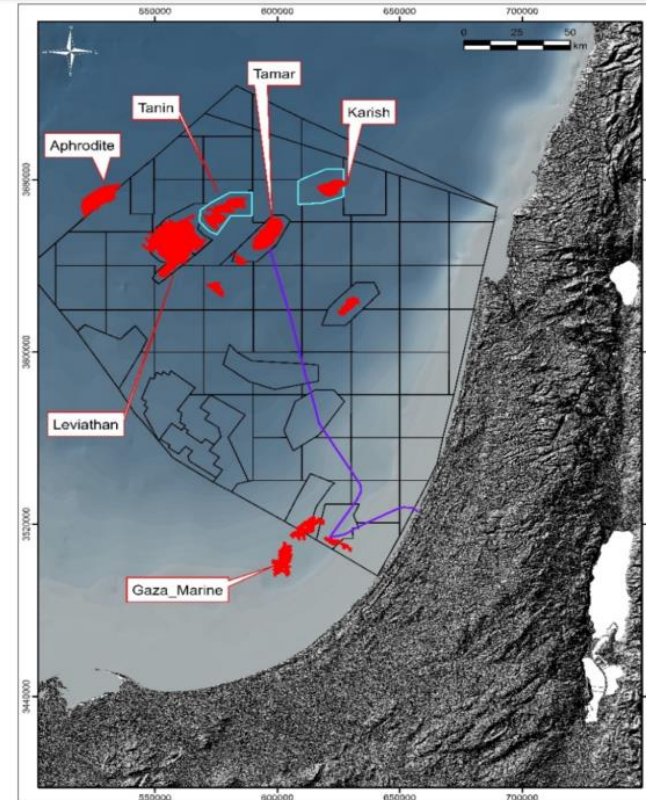


# Recent activities following Energean acquisition of Karish and Tanin discoveries

1. Energean awarded 5 blocks in 1<sup>st</sup> Israel offshore license round – ONGC awarded 1 block,
2. ENI discover 6+ Tcf in the Calypso field (Cyprus),
3. Lebanon award 2 blocks (4 and 9) to a consortium of ENI, Total and Novatek,
4. Turkish war ship prevents ENI drilling in Cyprus block 3,
5. Exxon Mobil prepares to drill first well in Cyprus – potential game changer

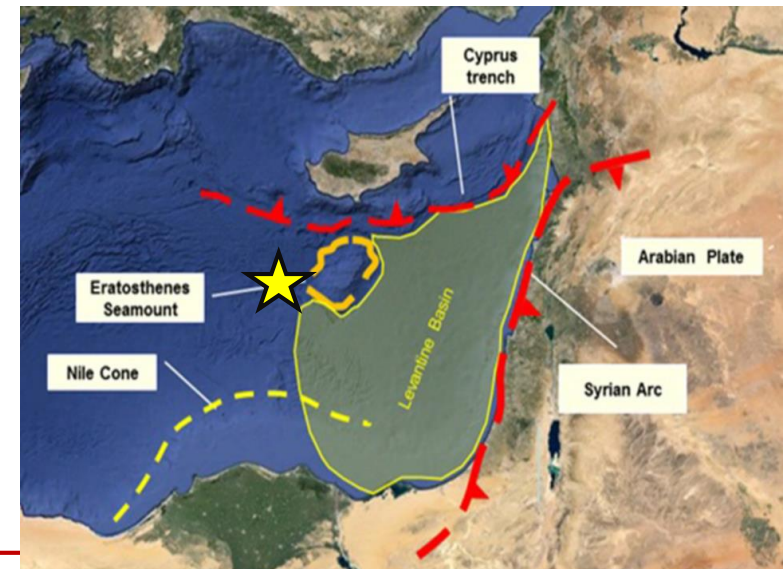
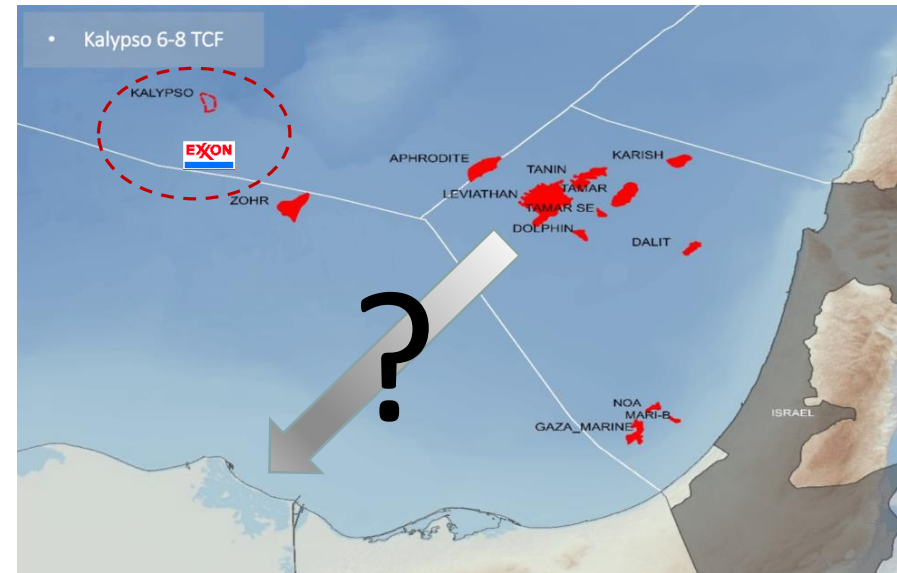

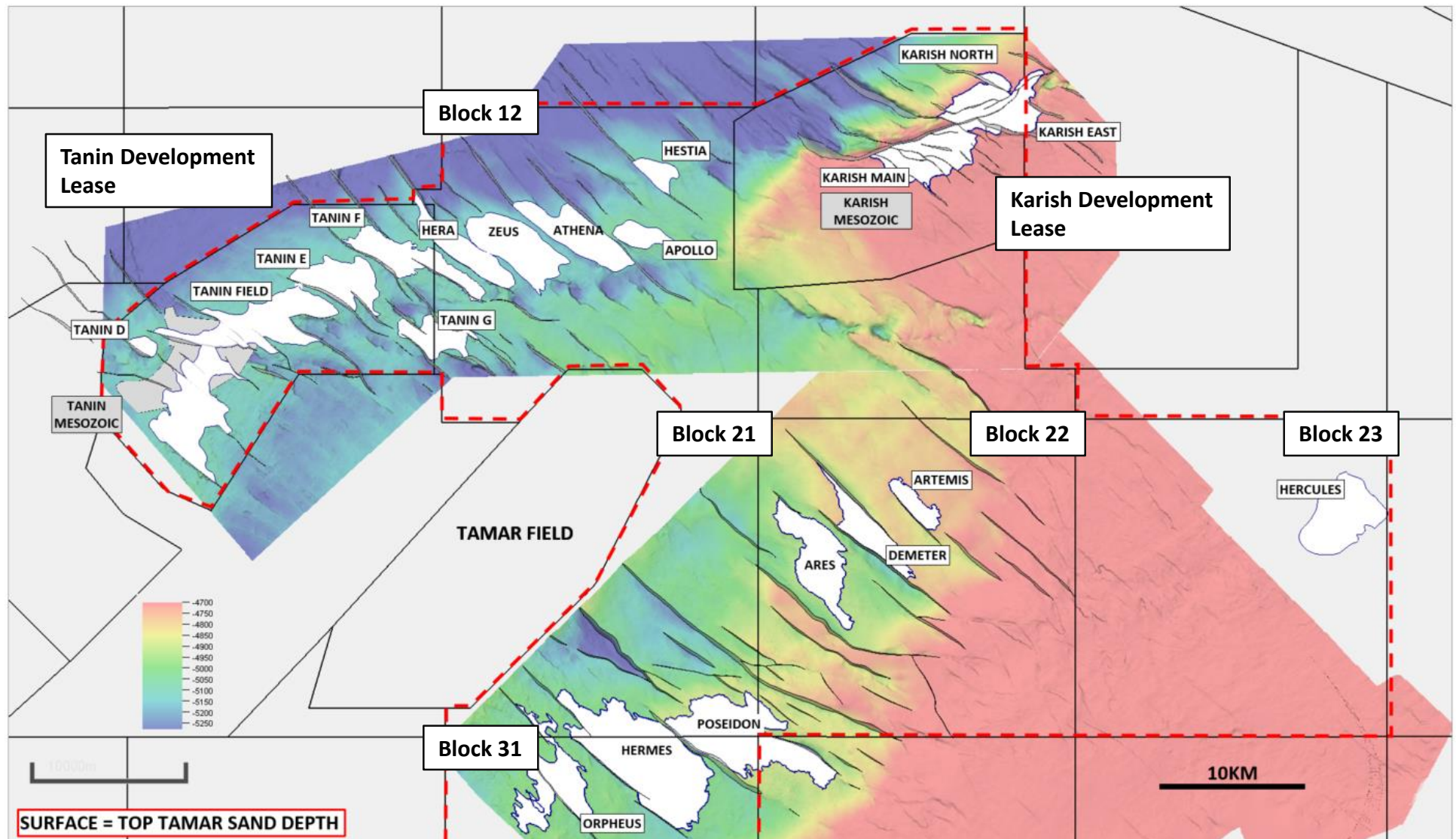


# Calypso.....a regional game changer?

- February 2018 – ENI (and Total) announce a “significant” discovery of “lean gas” in a “Zohr-like” structure in block 6 (Cyprus),
- Later press releases indicate gas resources are in the region of 6 – 8 Tcf (210 – 280 BCM),
- Subsequent speculation that this signals the “end of the Leviathan field” – presumably because Calypso gas will saturate the Egyptian LNG plants with a new source of feedstock,
- Calypso is clearly a “game changer” but unlikely that it is a “bad result for Israel”,
- Exxon’s “mega-prospect” in Block 10 significantly de-risked by Calypso discovery,
- An Exxon discovery would likely trigger a pipeline to Cyprus and then either a new regional onshore regional LNG plant or the much discussed East Med. pipeline to Europe,
- Does Calypso therefore not really spell a reduction of new supplies to the Egyptian LNG plants?

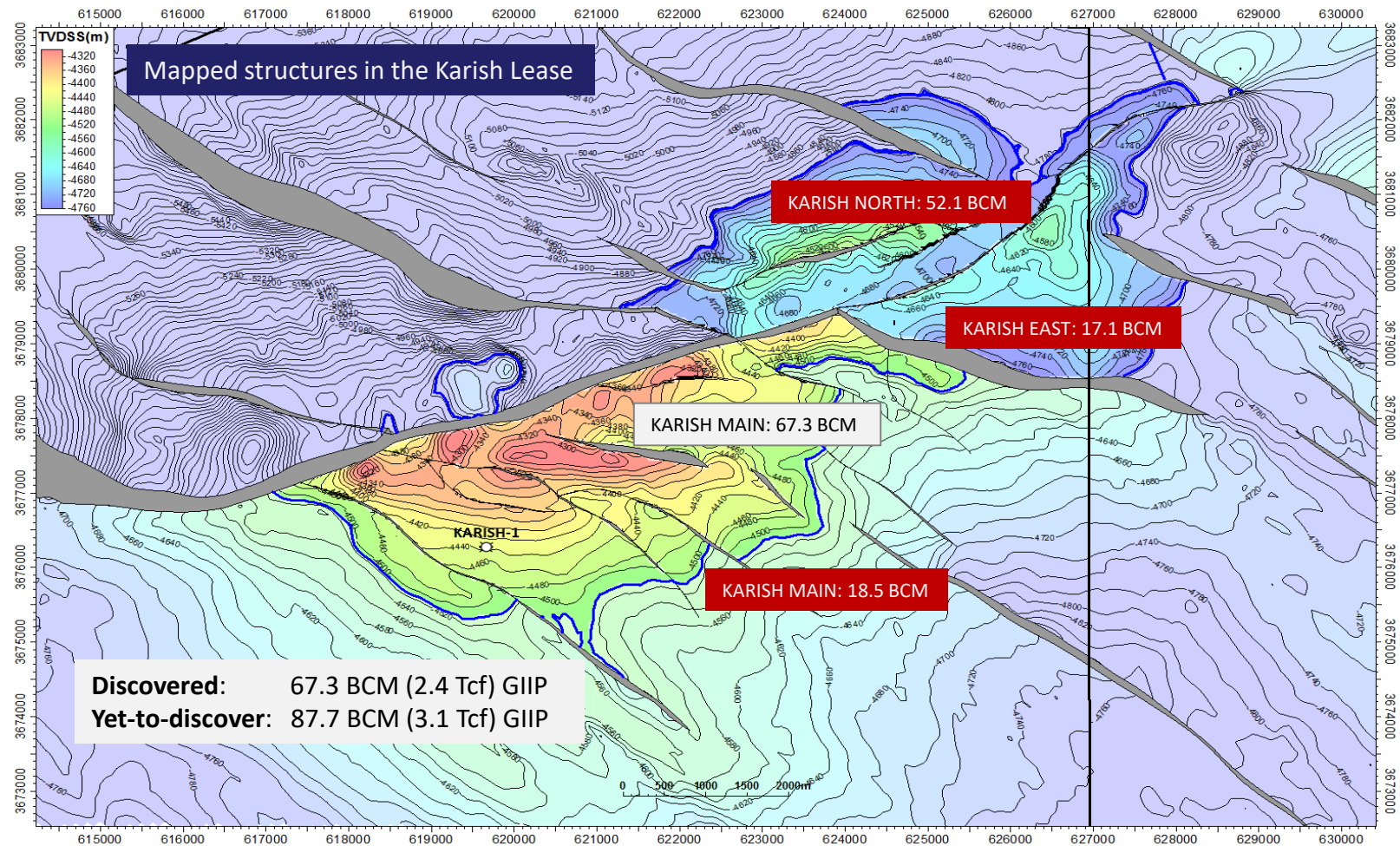

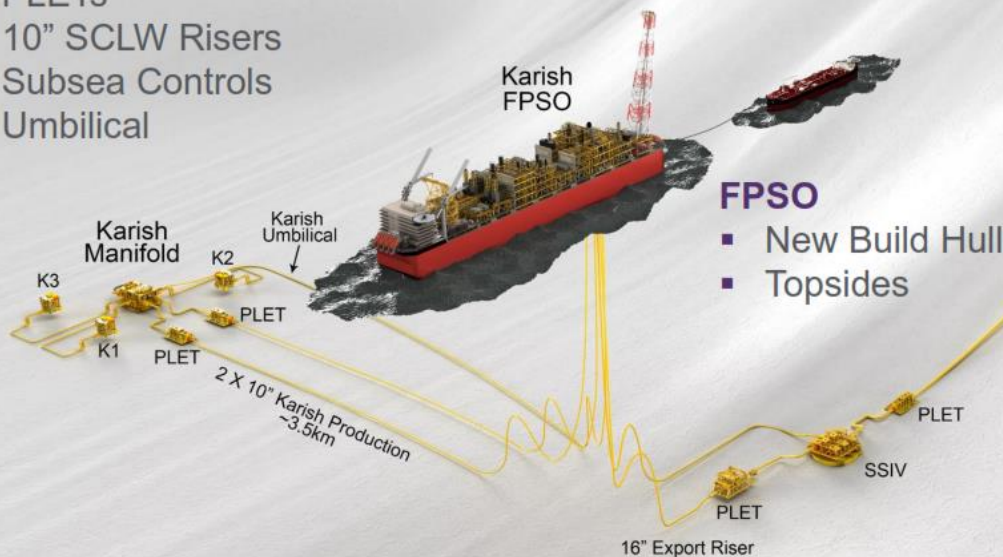

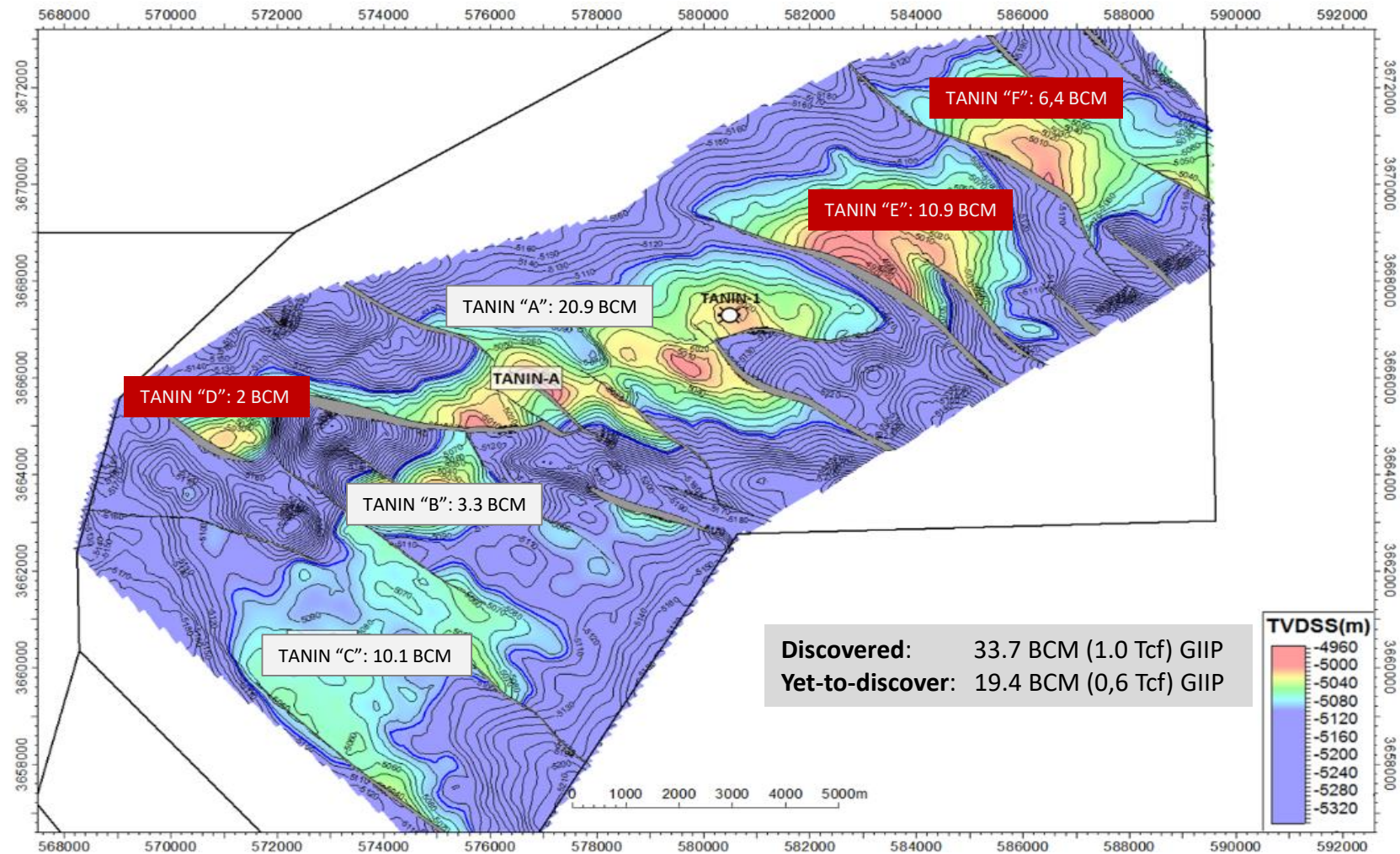

# Tanin Lease: Discovered and undiscovered accumulations

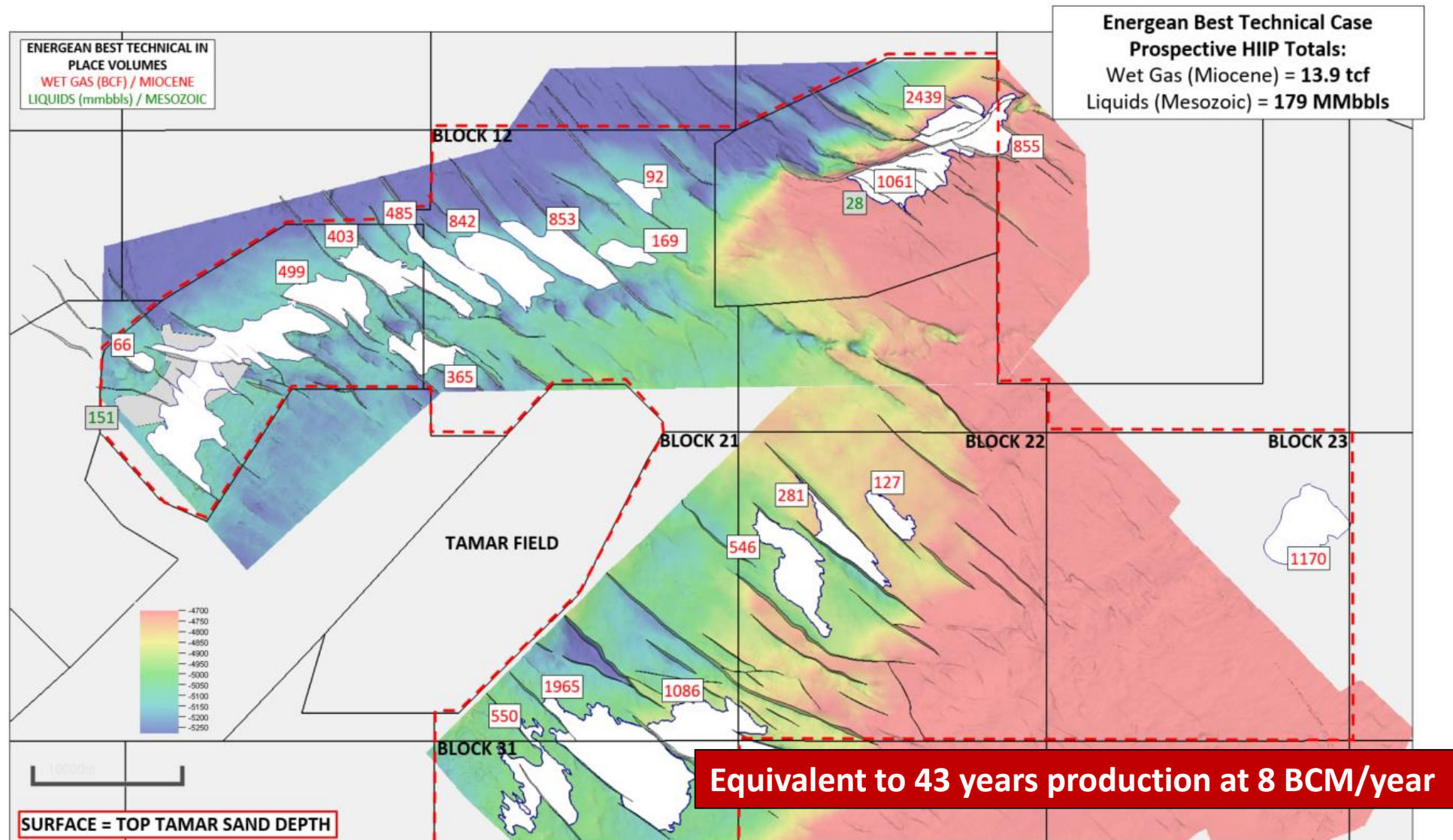

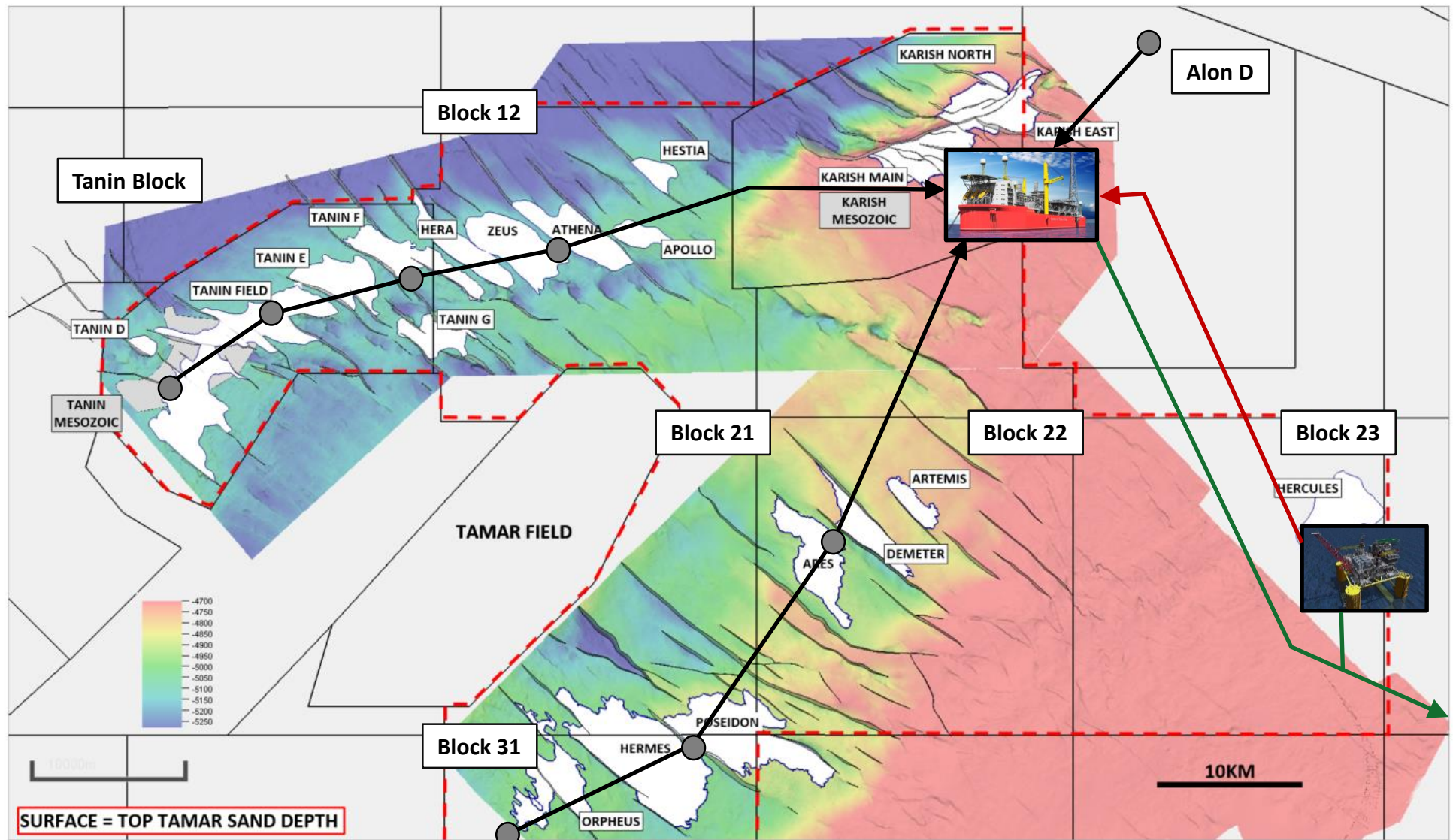
